

Statements required in notice if the proposed tax rate exceeds the no-new-revenue tax rate but does not exceed the voter-approval tax rate, as prescribed by Tax Code §26.06(b-2).

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.615890 per \$100 valuation has been proposed by the governing body of County of Anderson.

PROPOSED TAX RATE \$0.615890 per \$100
NO-NEW-REVENUE TAX RATE \$0.595891 per \$100
VOTER-APPROVAL TAX RATE \$0.659413 per \$100

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for County of Anderson from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval rate is the highest tax rate that County of Anderson may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that County of Anderson is proposing to increase property taxes for the 2020 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 24, 2020 at 9:30 AM at Anderson County Commissioners Court / 703 N. Mallard, Suite 102, Palestine, Texas 75801.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, County of Anderson is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Commissioners Court of County of Anderson at their offices or by attending the public hearing mentioned above.

The 86th Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by County of Anderson last year to the taxes proposed to be imposed on the average residence homestead by County of Anderson this year.
