Articles Number 111.002 and 111.003 of the Local Government Code of this State designates the County Judge as County Budget Officer and directs him/her, with the assistance of the County Auditor, to prepare a County budget each year for the next ensuing year. ORDER LEVYING THE TAXES FOR ANDERSON COUNTY, TEXAS FOR THE YEAR 2010

BE IT ORDERED BY THE COMMISSIONERS' COURT of Anderson County, Texas that ad valorem taxes be and the same are hereby-levied for the year 2010 on all property situated in and taxable within the limits of Anderson County, Texas on the First day of January 2010 except so much thereof as may be exempt from taxation by the Constitution and laws of this State or by the Constitution and laws of the United States, as follows, to wit:

- (l) A tax of and at the rate of .43712 on each ONE HUNDRED DOLLARS valuation of all taxable property in said County for County Revenue purposes.
- (2) A tax rate and at the rate of .04933 on each ONE HUNDRED DOLLARS valuation of all taxable property in said County for DEBT SERVICE purposes.
- (3) A tax of and at the rate of .02455 on each ONE HUNDRED DOLLARS valuation of all taxable property in said County, formerly levied as State Ad Valorem which was approved, authorized and assumed by a majority of the qualified property tax-paying voters of Anderson County, Texas voting in a Special Election held upon the 7th day of April, 1951. (FARM TO MARKET/FLOOD CONTROL FUND)
