Judge Carter declared a quorum has been established.

Commissioner Strickland stated this is his last meeting and that it has been an honor and a privilege to serve on Commissioners Court.

Judge Carter stated the purchase of the ArgiLife building has concluded; the building is located at 2505 N. Center Street, the building will be remodeled with the intent of moving in within 3-4 months.

Mr. Jason Walker expressed discontent on not being able to gain access to his property and is present to support the reopening of CR 3732; notification of road closings by signage is inadequate for absentee land owners.

Commissioner Strong stated he was approached by Mr. McDonald who requested an extension of of County Road 3732.

Mr. Rick McDonald stated he is requesting the County open an additional 200' of County Road 3732 at no additional cost to the County. Mr. McDonald stated he maintains that stretch of road and mows along the sides; if the County were to decide to maintain that portion of the road, Mr. McDonald is willing to pay for the rock to be used; a gate would be installed at the end of the road, and Mr. McDonald is willing to pay for any "Dead End" signs that the County might require.

Commissioner Barker stated County Road 3730 was never officially closed; the road was left open by Jury of View in 2006.

Commissioner Strong stated a portion of the 200' referenced is owned by Mr. Ashby who would need to be consulted as well.
