Judge Carter called the meeting to order at 9:00 a.m.

ITEM 2. ESTABLISH A QUORUM

Judge Carter declared a quorum has been established.

ITEM 3. PUBLIC FORUM

Darrell Brewer, EMS Coordinator stated this past year the CERT (Community Emergency Response Team) volunteers contributed 1,178 hour through 18 events with 60 participants; according to the U.S. Financial Accounting Standards Board, the hours in Texas are worth \$21.35 per hour which means Fannin County volunteers donated \$25,150 worth of their time. Mr. Brewer stated Texas has received the Individual and Community Awareness Award for outstanding service; Fannin County volunteers were in large part a contributing factor in Texas receiving that award.

Gail Young, Tax Assessor Collector stated the Step up Scale Down program starts tomorrow and there are currently 17 employees signed up to participate.

Judge Carter stated Mr. Venable who was honored with a proclamation this past year for 65 years of marriage has passed away.

Commissioner Strong stated the signage for the James E. Taylor section of Highway 56 was installed this past Friday and the memorial service will be on the 19th of January.

Scott Dyer, Auditor stated there has been an unusually high level of medical bills this year; there is also a medical surplus distribution from the County Health insurance; it is recommended the budget be amended to reflect an increase of \$52,662 which would then to added to the Inmate health care line item 10-565-405.

Scott Dyer, Auditor stated funds are requested in the amount of \$15,338 from Contingency to go into Prison medical; this will lower the Contingency fund to \$90,662; the funds will cover future costs for the rest of the year; the total between Agenda Items 13 and 14 will be \$68,000.

Commissioner Barker asked if the inmates requiring extraordinary medical care were still in the jail. Mr. Dyer stated no, both inmates had been released.
