### COMMISSIONERS COURT MINUTES

#### Order #25-173

August 11, 2025 Austin County Commissioners Court met in the 2<sup>nd</sup> floor Courtroom at the Austin County Courthouse with the following present:

Motion to Approve: Commissioner Reed, 2<sup>nd</sup> Commissioner Mikel, passed (4-0)

## 1. Budget Discussion

Updated copy of budget was presented to the court. Total budget of \$26,854,346.00 was presented.

Billy Doherty (County Auditor) presented a correction to the tax rate making it .03723 and a correction to the general rate making it .312935.

## 2. Public Hearing on FY 2025-2026 Budget

Bryan McAuley, representing Friends of San Felipe and the Austin County Historical Commission, stated our world is changing and at a county level he knows the money provided by them is insignificant. Court thanked Bryan for all he does. Judge Lapham believes a specific line item has been placed in the budget for funds provided by them.

Judge Lapham stated this will be the proposed budget.

## 3. Petitions or Requests from the Public.

Commissioner Mikel announced Mill Creek Bridge is open to traffic. Bridge has no weight limit. The public is asked to be patient while the old bridge is taken down. The road will be addressed after old bridge is taken down.

# 4. Discussion regarding resolution supporting a TxDOT feasibility study for Highway 36, Sealy, truck route.

Resolution presented to the court. This will be the first step so TxDOT can start looking into it.

# 5. Consideration and action to approve Austin County Employee supplemental insurance proposals

Tara Wise (HR Administrative Assistant) presented NTC Insurance proposal to the court.

Commissioner Reed expressed concern for coverage with the price change.

Judge Lapham asked Tara Wise (HR Administrative Assistant) when a decision needs to be made.

Tara Wise (HR Administrative Assistant) advised we need to decide before open enrollment in November.

Commissioner Reed suggested presenting the proposal to county employees for their feedback.

Tara Wise (HR Administrative Assistant) will send information to employees.

Judge Lapham stated will bring back to court in September.

# 6. Discussion regarding clarification of Permitting and Engineering Fee Schedule and as appropriate.

Erica Resendez (Planning and Development) and Jonathan Hopko (County Engineer) reexamined the fee schedule and corrected it. Penalty Fees were originally left out and have been added. Jonathan Hopko (County Engineer) requests the Fee Schedule be looked over and determine if court is still in agreement. Website has been updated also.

Commissioner Rinn inquired on the cost for reinspection.

Per Judge Lapham, cost will be determined by the amount of re-inspections needed, multiplied by the fee for service.

Motion to Approve: Commissioner Cerny, 2<sup>nd</sup> Commissioner Reed, passed (4-0).

# 7. Consideration and action to declare 2014 Ford F-250 Crew Cab 4x4, VIN 1FT7W2B6XEEA34824 as surplus.

Sheriff Brandes stated this is the old work truck. The truck still operates and would like to offer it to the precincts to use or declare it surplus.

Judge Lapham advised we will hold the vehicle for 30 days.

# 8. Discussion and action regarding S.O. transport vehicle approved 07.28.2025.

Lt. Donald Durracq (Sheriff's Office) expressed the approval at previous court not to exceed \$44,000. However, after approval and contacting Rockwall Ford the vehicles on the lot were no longer available.

Judge Lapham suggested Lt. Donald Darracq (Sheriff's Office) inquire with other vendors.

After working under Judge Lapham, Lt. Donald Darracq (Sheriff's Office) was able to locate a vehicle at Chastang Ford. The truck has been purchased for \$41,985.00 and is in the possession of the Sheriff's Office.

Commissioner Reed motions to approve purchase of transport vehicle from Chastang Ford instead of Rockdale Ford.

9. Consideration and action to approve specifications and plans for the Austin County GLO Mitigation Competition Program #22-085-007-D235 for the Sector 2 area and approval to begin bid process for construction services for this work.

Per Commissioner Reed, after talk with the engineer he is ready to begin construction with GLO.

Commissioner Cerny motioned to approve for Austin County to let the bid process begin.

Commissioner Mikel converted two Assistant Foreman positions to (1) foreman position and (1) operator position.

Commissioner Reed advised that Precinct 4 will have an increased volume of work in August and September. Therefore, he will consider adding an additional full-time operator.

## 18. Building Projects Update.

Daniel Sanchez (Shellback Construction) presented current building project updates for new EMS buildings, Wendt Street building repairs, county generators, and new Command Building.

Daniel Sanchez (Shellback Construction) presented generator proposals from Loftin and WPI. Industry standard is to charge individually which made Loftin the cheaper proposal at \$19,481.00. Benefit to county would be a one stop shop with Shellback Construction. Austin County would contact Daniel Sanchez (Shellback Construction) who would then contact Loftin. Loftin is also contracted with City of Bellville so they are also familiar with the area. Loftin has been very responsive and came out 4 times to inspect generators to ensure they had the correct information on the generators. If there is an outage Loftin will be contacted and response time will be approximately 2 hours.

Daniel Sanchez (Shellback Construction) advised contract states 3 years however, he does not want to agree to 3 years so he will talk with Loftin on signing for a year and see how things go. If Loftin does not agree to a 1-year contract, Daniel Sanchez (Shellback Construction) will come back to the court.

Commissioner Reed asked if Loftin only does service or will they install also.

Per Daniel Sanchez (Shellback Construction), Loftin will handle install and servicing.

Billy Doherty (County Auditor) inquired on the cost for after hour and weekend service.

Daniel Sanchez (Shellback Construction) advised he is not sure on exact cost but believes it partially depends on what type of service is being performed. Plan is for maintenance check twice a year.

Judge Lapham inquired with Billy Doherty (County Auditor) for fund coverage. Billy Doherty (County Auditor) is okay with this amount.

Commissioner Reed motioned to go with Loftin through Shellback Construction for maintenance on the generators semi-annually.

Motion to Approve: Commissioner Reed, 2<sup>nd</sup> Commissioner Mikel, passed (4-0)

Judge Lapham stated he spoke with Lone Star Prestress who will donate the building to put communications in for Westcom.

Commissioner Reed thanked Judge Lapham for looking into it and inquired if the building is prebuilt. Judge Lapham advised it has not been built yet.

Commissioner Cerny feels it's worth going with that building right away.
