Sheriff Brandes discussed Computer Aided Dispatch (CAD) System. Officers in attendance were Chief Tollett, Sealy Police Department; Captain Smalley, Bellville Police Department; Chief Frank Serrato, San Felipe Police Department and from Sheriff's Office, Judy Majewski, Dispatch and Al Cordeiro. Sheriff's Department will pay \$87,000 for HUB (set up/software) through forfeiture funds. Law Enforcement entities, Fire Departments and EMS will be responsible for paying their own licensing fees, equipment and maintenance fees. Currently Austin County is paying Harris County \$3,000 a year maintenance fee for a radio system. The maintenance fee for CAD System with Tyler will be \$19,479 a year. The 911 Board has given the Sheriff's Office \$15,000 toward purchase of system.

Commissioner Turner requested a special workshop on this item. Everyone present is in support of this, but no elected officials in attendance that have authority to sign contracts.

Commissioner Turner made a motion to table the agenda item, motion died for a lack of second.

Commissioner Reichardt asked if entities in attendance had discussed this with Councils? All had discussed with City Managers.
