August 10, 2020, Austin County Commissioners Court met in the Basement Meeting Room at the Austin County Courthouse with the following present:

Per Judge Lapham, there was a \$26,000 decrease in the Juvenile Probation budget.

Received Tax Revenue worksheet from the Appraisal District. No-new-revenue tax rate is the Effective Rate for General Fund .40024. Per Billy Doherty (County Auditor), the .40024 does include .0604 Debt as well. Voter Approval Rate is the Rollback Rate.

Carrie Gregor (County Clerk) requested an additional Deputy Clerk to assist with the collection of over \$1 million outstanding fees owed to the County. This will add about \$40,000 to the budget. Per Judge Lapham, by adding a position, this takes the budget from a \$26,000 decrease from last year to a \$15,000 increase from last year. Ms. Gregor spoke with regard to her Archive Plan. Fund total is \$347,635 to work on old books. Estimated

cost to preserve all the old books is approximately 2 million. Will work on books a little at a time because of cost to preserve books.

Sharon McCowin (Human Resource), requested a pay increase for her Administrative Assistant. Commissioner Reichardt suggested \$16 per hour. This will add \$4,300 to the budget.

Per Judge Lapham, had a change in his budget by eliminating one position and adding partial funding from the eliminated position to Development Coordinator position. Person will have to have DR license and Flood Plain Administrative license. Decreases funds spent and positions.

Per Billy Doherty (County Auditor), having billing issues with AT&T. County currently spending \$10,000 on an unknown circuit.

Per Kim Rinn, there will be more early voting days that requires election workers. Estimated election costs is \$32,338 for labor. Will have to pay first then may receive a reimbursement at a later date. Creates an increase of \$14,000 in the budget.

Per Walter Morrow (EMS Director), went through the numbers again. Decreased \$63,662 in salaries and benefits. There was a miscalculation in FICA and retirement numbers. Total budget is \$3,035,060. Saves \$160,000 than budget presented.

Per Judge Lapham's calculation, added \$36,000 for position for County Clerk, \$4,300 for HR, \$14,000 for election workers, took off \$160,087 for EMS, totals \$18,251,302. Compared to last year this is \$131,924 less than last year's budget.

Judge Lapham estimated revenue based on last year's rate County thought would be \$2,237 in the red, but will be \$12,000 in the black.
