1. Public Hearing regarding erecting stop signs at Skalak Road and Tiemann Road, Precinct 2

2. Action as appropriate from Public Hearing

Put a stop sign on Tiemann Road.

Julie Jennings and Angela Leschper addressed the Court with concern for subdivisions coming in around their subdivision.

Gene Svoboda spoke with regard to hazardous roads in his area.

4. Workshop on subdivision regulations.

Workshop began at 9:10 a.m.

There is an issue with Developers not getting all the proper signatures for subdivisions.

Per Jesse Skinner (Assistant District Attorney), with the Interlocal Agreement in place the County relinquishes its authority to the City. County has authority over sewage facilities and drainage. County can speak with Developer. If Developer doesn't comply can impose fines.

Commissioners and County Judge reviewed and discussed Subdivision Regulations. Will bring back to Court on February 22, 2021 with proposed changes. Proposed changes in the paper March 22, 2021 with hearing set April 12, 2021.

Court recessed at 10:57 a.m.

Court reconvened at 11:06 a.m.

Judge Lapham presented estimate for \$36,200 from Honeycutt Air Conditioning to repair the air conditioning at Wendt St. building.

Commissioner Lamp requested a second opinion. Per Judge Lapham, the Court could, but Honeycutt has been working on a solution for the A/C at Wendt St. building.

Approve Honeycutt Air Conditioning to repair A/C at Wendt St. building for \$36,200 to be paid from 101-55310-127 – Major Repairs/Co. Bldgs.

A final walk-thru is scheduled this week at the Sealy EMS. If all is fine, will move into new building over the weekend.

Per Commissioner Reed, the grant his precinct received is working well on the five roads. Culverts are going in fast.
