Since Adult Probation will be in a building with other offices, they need locking cabinets. District Attorney's Office has filing cabinets they could have, but not sure they are the right size.

Per Billy Doherty, will check prices with Cravens.

Commissioner Lamp asked if Adult Probation could move last, to determine if the filing cabinets from District Attorney's Office could be used by Adult Probation. Check if Adult Probation can find some funds from their department.

Per Judge Lapham, will order small filing cabinet for them.

Commissioner Reed asked if there was a game plan for the move. Per Judge Lapham, Juvenile Probation will move to the third floor with small court room. Judge Lapham's office will remain where it is. Treasurer and Auditor moving into County Clerk's Office. Shannon moving to glass side of the clerk's office. Once everyone has moved, the elevator can be worked on. It will take about 2 months. Second floor will be vacant for the time being. Will use second floor court room for Commissioners Court.

Commissioner Reed asked about cleaning staff for Justice Center. Per Judge Lapham, Ofelia and Reyna will clean the Courthouse, Justice Center and building across the street. Will get someone part-time to clean buildings in Sealy and Wallis.
