Motion to Adopt: Commissioner Reed, 2nd Commissioner Rinn, passed (4-0). **Order #22-177**

1. PUBLIC HEARING REGARDING COUNTYWIDE POLLING

Public Hearing opened at 9:05 a.m.

Kim Rinn (Tax Assessor-Collector) updated the Court about Countywide voting from May 7, 2022 election. Will have Countywide voting for May 24th and November elections. Party Chairs Chuck Beers and Pat Burns agreed, both parties in favor of Countywide voting. Buddy Koenig (Retired Republican Chair) in favor of Countywide and asked they keep a paper trail as well.

Public Hearing closed at 9:12 a.m.

2. Petitions or Requests from the Public.

Commissioner Reed spoke with regard to Feral Hog Grant. Stacey Villarreal (Agrilife) spoke with regard to advertising more and improving program. There are matching grants County could apply for as well.

3. Discussion and action as appropriate regarding building projects and financing.

Per Judge Lapham, offices moved in at Justice Center. Kenny Burns (Burns Architect) sent drawings for EMS buildings. Changed a little bit by moving server and electrical rooms into one room. Moving forward with EMS stations. Jail Commission is coming back on Wednesday to re-inspect Justice Center. There was an issue with smoke detectors. Inspector thought a generator was needed at the Justice Center, but County met with Jail Commission who stated otherwise. Commissioner Reed asked if there will be a generator on the EMS buildings. Per Judge Lapham, should be drawn into plans for EMS stations.

Per Commissioner Rinn, he and Commissioner Reed had a meeting with departments and contractor. Contractor to begin on renovations end of May, beginning of June. Will start with small conference room first.

Per Commissioner Lamp, contractor to complete fencing behind Justice Center. Light poles have been pulled at EMS location. Rerouted internet to 911 office. Working with City to move water meter.

4. Discussion and action as appropriate regarding road construction projects.

Commissioner Lamp received an inspection report for Mill Creek Road bridge on Sandy Creek issues. Requests bridge be added to list of projects. Because of current two bridge projects in Precinct 2, will not cost the County additional funds. Per Commissioner Lamp, he owed \$59,000 from other matching projects. Since Commissioner Rinn is starting his two bridge projects, Precinct 1 can use those for matching projects. Commissioner Rinn stated the two bridges in Precinct 2 are not long enough to qualify for TxDoT replacement, but Commissioner Lamp can use them for matching funds for his bridge projects. Per Commissioner Rinn, Precinct 1 isn't taking any money from Precinct 2.

Commissioner Reed met with contractor about bridge on Chew Road. The bridge is fine. A beam was added underneath, but never painted because of rust. Getting contractors price before saying yes.

Commissioner Cerny didn't get bridge report for Franz Road yet. Definitely interested in following up.

Judge Lapham asked about time frame of projects. Commissioner Lamp stated once Precinct 2 starts construction, time frame will begin. Two projects in Precinct 2 are about half million. Commissioner Rinn stated still waiting to hear from contractor. Has within a year to start.

Commissioner Rinn waiting for start date for two bridges. Doing routine maintenance.

Per Commissioner Cerny, contractor moved equipment to Sealy and Kulow Road bridge to begin work this week. Doing routine maintenance. Will begin shredding.

Commissioner Reed has been shredding and doing routine maintenance. Had an issue with roads that were repaired last year with a contractor. County has one-year warranty. Called contractor and should be out this week.

Commissioner Lamp doing routine maintenance.

Billy Doherty (County Auditor) spoke with regard to road material price increases. All counties in the country are having same problem. Option 1, Court can vote per vendor, per increase up to 25% above bid price. Once increase reaches 25% above bid price, will go out for bids. Option 2, re-bid road materials. Can approve 25% increase and purchase what is needed to maintain roads.

Will come back.

5. Consideration regarding allowing a private vendor to set up on county property and action as appropriate.

6. Discussion and action to amend Compensation Order adding "Deputy Cadet" to patrol classifications.

Donald Darracq (Sheriff's Office) spoke to the Court with regard to Deputy Cadet position. The agreement between Sheriff's office and individual would be for a two-year commitment. The employee would be in school for the first seventeen weeks before beginning patrol. Cost of police academy is \$3,500 which would be paid from Sheriff's training budget. Currently have two – three open positions in patrol. Would only send one employee at a time. After police academy is complete and employee decided to leave the County, the only recourse would be to sue employee to recoup costs. Commissioners asked what is starting pay while attending Police academy. Deputy Cadet pay is \$23.48. Commissioners didn't agree with paying an employee \$23.48 while attending school. Court prefers to pay \$15 – \$18 due to other employees pay. Will bring back.
