Motion to Adopt: Commissioner Reed, 2nd Commissioner Lamp, passed (3-0). Order #22-274

1. Public Hearing regarding abandoning Ross Street and George Clark Street East of Jackson Avenue, Cat Spring, Texas.

Public hearing opened at 9:03 a.m.

No one showed up to speak.

Per Commissioner Cerny, researched parcels. No additional information or owners.

Give County Judge permission to sign whatever paperwork needed.

George Eberly (Eberly Ranch) spoke with regard to a projected subdivision. Subdivision will loop airstrip. Wilson Engineering is doing work. Request Tottenham to be paved up to the subdivision.

BUDGET WORKSHOP

Budget workshop opened at 9:09 a.m.

Kim Rinn (Tax Office) requested one full-time position specifically for elections at \$25 per hour.

Court agreed need to look at clerical employee pay.

Commissioner Rinn spoke with regard to Road & Bridge allocations.

Captain Hicks stated if salaries were structured in tiers, it would help budget.

Per Commissioner Lamp, if County had an overtime policy, it would be better. Employees required to take time off puts the Department behind in other work.

EMS, Dispatchers, Jail and Sheriff's Office employees get overtime pay.

Auditor and Treasurer will work on tier structure.

Budget workshop closed at 9:46 a.m.

6. Discussion and action as appropriate to set 2022 - 2023 proposed salaries for elected officials.

Lance Johnson (Constable Pct. 1), requested his pay be increased to the same as Precinct 3 and 4's salary. Per Johnson, he is very busy and all his service fees go back to the County.

Donald Darracq (Sheriff's Office) requested Sheriff Brandes pay increase to \$80,000.

Increase Constable, Pct. 1 to \$30,872.

Motion to Approve: Commissioner Lamp, 2nd Commissioner Reed, passed (3-0). Order #22-277

Approve proposed Elected Officials salaries as presented with change to Constable, Pct. 1 salary.

Motion to Approve: Commissioner Reed, 2nd Commissioner Cerny, passed (3-0). Order #22-278

7. Jail Museum Progress Report Presentation by Bruce Noviskie

Repaired doors, roof, plaster in interior walls and living quarters. Installed storm windows. Upgraded electrical system.

Future projects are installing insulation for jail section. Cost is \$17,820. Install HVAC. Cost is \$21,300. Remove rusted paint and re-paint. Cost is \$325,000. Because of cost, will do in parts, and apply for grants.

Average visitors 600 – 800 per quarter. Receive \$3 per person, which is \$9,000. County usually gives \$20,000 to help maintain museum. Bellville EDC also contributes.

Bruce Noviskie thanked the Court for its support.

8. Discussion and action to amend the Austin County Hazardous Mitigation Plan/City of Sealy section.

Per Roy Mercer (Emergency Management), amendment is a wording change to apply for grants.

Approve wording change.

Per Commissioner Rinn, waiting on baseboards and trim. Cracked plate glass was replaced.

Per Commissioner Lamp, Wade Baggerly (Sheriff's Office) and trustees washed the striping in parking lot at Wendt Street. Wade and trustees can re-stripe. If trustees do the work, it will be a fraction of the cost than bid.

Allow Wade Baggerly and trustees to re-paint parking lot stripes, not to exceed \$500.

Per Billy Doherty (County Auditor), July 8, 2022 was the deadline for Goeke Construction to finish punch list. Jonathan Anderson (Burns Architect) will be here Thursday to do a walk-thru.

Per Sheriff Brandes, water issues are supposed to be fixed.

Per Commissioner Lamp, wants to put up fence on backside of Pct. 1 yard.

Per Sheriff Brandes, fencing is complete.

Gate at the Justice Center is working fine.

10. Discussion and action as appropriate regarding road construction projects.

Per Commissioner Reed, doing routine maintenance.

Per Commissioner Lamp, spoke with Waller County Asphalt, was able to purchase material at a discount. Getting limestone from Giddings, but having trouble with transportation issues.

Per Commissioner Cerny, 28 days to cure Kulow/Sealy bridge. Doing routine maintenance.

Per Commissioner Rinn, Kenny Hall and Skalak Roads completed. Doing routine maintenance.

Per Commissioner Lamp, three bridges (Kiemsteadt Road, Woodley Road and Nelius Road) will start end of July/early August. Steckbottom/Grubbs Road bridge beams are coming in. Once beams are in, will take out old bridge. After approaches are done, will do fence for land owners as agreed. Will be completed before starting FM 331. Continuing with routine maintenance.

Tegeler has truck on hand for \$41,907. New equipment purchase line item has \$40,294. Will pay remainder with contingencies.

Purchase truck not to exceed \$41,907.
