

COMMISSIONERS COURT MINUTES

On **October 25, 2013** Austin County Commissioners Court met in the Commissioners Court Meeting Room, at the Austin County Courthouse with the following present:

Consideration/Adoption of Agenda

Motion to Adopt: Commissioner Turner, 2nd Commissioner Rinn, passed (4-0). Order #13-383

1. Petitions or Requests from the Public

Tom Sherman thanked Commissioner Turner for attending the Fort Bend County Subsidence District meeting and discussed the EP App/MTQ-Denial.

2. Consideration and possible action to accept deed as surveyed for a proposed turnaround area at the end of Zievert/Ludeke Road located in Precinct 1.

Per Commissioner Turner, the intent is to protect a piece of property from ever being landlocked. Access to this has been on a road questioned as to whether it's private or not. This does not in any way imply or guarantee that the County will maintain this road. In 1983 Zievert/Ludeke Road was established as a public road. Inadvertently in 2005, Zievert/Ludeke Road was left off the list and not in the Court Order.

5. Discussion regarding culvert permit application process and action as appropriate.

Commissioner Reichardt discussed the current culvert permit application process and possible changes to the process. He will draw up a new culvert permit application, and bring back to November 6th meeting.

6. Consideration and possible action to authorize hardship variance for District Attorney's Office employee to carry over three unused vacation hours in Fiscal Year 2012-2013 through November 15, 2013.

Motion to Authorize: Commissioner Turner, 2nd Commissioner King, passed (4-0). **Order #13-387**

7. Consideration and possible action to authorize \$200 clothing allowance per quarter for investigators as plain clothes officers.

Two hundred (\$200) per quarter for 12 slots. Clothing allowance for 1st quarter will be paid in January payroll, the 1st pay period in the 2nd quarter.

Motion to Authorize: Commissioner Reichardt, 2nd Commissioner Turner, passed (4-0). **Order #13-388**

8. Discussion regarding Bluebonnet Groundwater Conservation District Notice of Contested Case Hearing regarding applications of Electro Purification, LLC to be held on Monday, October 28, 2013 and action as appropriate.

Commissioner Turner told the Court that the stronger argument against these wells is to be made in subsidence than in water. Sealy, San Felipe and Wallis are pretty close to flood plain level, with the studies being used by the Fort Bend County Subsidence District. The southern end of our County could go down 3 feet over the next years. If it subsides 3 feet, that will put the center of some of our towns in the flood plain.

Motion to Authorize Resolution With Commissioner Turner To Represent Austin County: Commissioner Rinn, 2nd Commissioner King, passed (4-0).

9. Consideration and possible action to authorize hardship variance for Ira Wallace, land owner to Austin County On-Site Sewage Facility Order for aerobic system with public water to serve household for self and daughter in Precinct 1 on 1.1 acre tract.

Motion to Authorize: Commissioner Reichardt, 2nd Commissioner Rinn, passed (4-0). **Order #13-390**

10. Discussion regarding County Transportation Reinvestment Zones (SB 1747) and action as appropriate.

State has appropriated money for county road repair for damages from oil and gas activity. County must form a designated County Energy Transportation Reinvestment Zone to be eligible for a grant for any damages that occur.

Motion to Postpone: Commissioner Turner, 2nd Commissioner Reichardt, passed (4-0). **Order #13-391**

11. Discussion regarding Texas Comptroller of Public Accounts letter of overpayment of County Sales tax and action as appropriate for repayment.

Austin County has been overpaid \$83,857.63 in county sales and use taxes. Judge Bilski would like to pay this back in 4 years instead of 1 year.

Motion to Reimburse in 4 years or Negotiate Otherwise: Commissioner Turner, 2nd Commissioner Reichardt, passed (4-0).

12. Consideration and possible action to authorize lease purchase intergovernment agreement with Great America through Brazos Valley Purchasing Solutions Alliance to replace Toshiba copier in Jail with Ricoh 3352 black and white copier.
