



**COUNTY OF ANDERSON, TEXAS
ORDER FOR PHYSICAL DISTANCING**

WHEREAS, a Declaration of Local Disaster was issued on March 19, 2020, for Anderson County due to a novel Coronavirus, now designated SARS-COV2 which causes the disease COVID-19; and

WHEREAS, on March 23, 2020, the Commissioners Court of Anderson County affirmed the Declaration of Local Disaster for Anderson County; and

WHEREAS, pursuant to Texas Government Code Section 418.108, the County Judge may enter such orders as may be necessary to protect the safety and welfare of the public during a local disaster; and

WHEREAS, the Senior Citizens, Pregnant Women, and persons with underlying health conditions are at high risk for complications and serious health issues from the disease COVID-19; and

WHEREAS, limiting the potential exposure of these populations to the virus will help avoid the risk of overburdening our health infrastructure;

THEREFORE, IT IS HEREBY ORDERED that all businesses are required to practice physical distancing among employees of at least 6 feet, whenever possible.

IT IS ALSO ORDERED that all residents are required to practice physical distancing at all times when you are away from home, except within family units.

THIS ORDER IS PUNISHABLE pursuant to Texas Government Code Section 418.173, failure to comply with this plan or with a rule, order, or ordinance adopted under this plan, including any executive order, proclamation or regulation issued the Governor during a State of Disaster, is an offense punishable by a fine not to exceed \$1,000, confinement in jail for a term not to exceed 180 days, or both fine and confinement.

THIS ORDER SHALL BE in effect until it is either rescinded, superseded, or amended pursuant to applicable law.

ORDER FOR DESIGNATED SHOPPING TIMES**

WHEREAS, a Declaration of Local Disaster was issued on March 19, 2020, for Anderson County due to a novel Coronavirus, now designated SARS-COV2 which causes the disease COVID-19; and

WHEREAS, on March 23, 2020, the Commissioners Court of Anderson County affirmed the Declaration of Local Disaster for Anderson County; and

WHEREAS, pursuant to Texas Government Code Section 418.108, the County Judge may enter such orders as may be necessary to protect the safety and welfare of the public during a local disaster; and

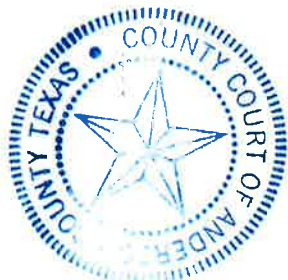
WHEREAS, the Senior Citizens, Pregnant Women, and persons with underlying health conditions are at high risk for complications and serious health issues from the disease COVID-19; and

WHEREAS, limiting the potential exposure of these populations to the virus will help avoid the risk of overburdening our health infrastructure;

THEREFORE, IT IS HEREBY ORDERED that grocery stores, supermarkets, warehouse stores, big-box stores, and dollar stores shall designate at least one hour per day on Tuesdays, Thursdays and Saturdays, as exclusive shopping times for the use of at risk populations (Seniors, Pregnant Women, and people with underlying health conditions). Notices of such designated times shall be posted on the door of each location. All stores are to keep a physical distance of at least six feet between patrons, to the best of their ability, whenever possible.

THIS ORDER SHALL BE in effect until it is either rescinded, superseded, or amended pursuant to applicable law.
